- The Automated Permanent Academic Account Registry (APAAR) ID Card or EduLocker is a one-of-a-kind identity number that will be given to all students

- in Indian institutions.
- This project is in keeping with the “One Nation, One Student ID” scheme of the National Education Policy (NEP) 2020.

What are its Objectives?

- **The APAAR ID Card was created with the following goals in mind:**
 - To provide pupils with a permanent academic identify.
 - To make it easier to track students’ academic development.
 - To simplify administrative procedures in the education sector
 - To avoid duplication of student records
 - To improve education sector transparency

To whom it Benefits?

Who will be protected under this?

- The National Informatics Centre (NIC) will manage the APAAR ID Card scheme on a day-to-day basis.

The National Institute of Standards and Technology (NIC) is a technical institution within the Ministry of Electronics and Information Technology.

Steps toward student data confidentiality:

- The confidentiality of student data is a significant concern in the APAAR ID Card scheme's implementation. The government has taken several steps to protect student data from illegal access. These steps are as follows:



- Storing student data in a safe place
- limiting authorized personnel's access to student

data

- Putting in place stringent data security protocols
- Auditing data security measures on a regular basis
- Furthermore, the government has created a data protection policy outlining the principles and procedures for collecting, using, and disclosing student data. The data protection policy adheres to the Information Technology Act of 2000 and other relevant laws.
- The government is committed to safeguarding student data confidentiality. The procedures taken to secure data security are intended to reduce the possibility of unauthorized access to student data.

Can parents revoke their permission to data as well?
